

## ROYALTY EXEMPTION REQUEST FORM

## For Products Bearing University Trademarks for Internal Use Officially Recognized University Entities

Officially recognized university entities (i.e., Colleges, Divisions, Departments, Programs, Student Organizations) are required to seek prior approval when ordering any products bearing any university trademarks (i.e. names, marks, logos and/or symbols) regardless if products are for internal, promotional, or resale. While each request is handled on a case-by-case basis, products purchased by a recognized campus entity for internal and non-cobranded promotional use are typically exempt from standard royalty fees applied to products bearing university trademarks with approval of this form. All products bearing university trademarks with approval of this form. All products bearing university trademarks which are intended to be resold as well as products cobranded with a third party entity given ARE NOT EXEMPT and will be subject to the appropriate royalty fees (Minimum 15%). Before ordering any product bearing any university trademarks, approval must be granted by the Office of Trademark Licensing. The following waiver must be completed and signed by the appropriate representative(s) prior to production. ITEMS NOT APPROVED FOR ROYALTY EXEMPTION MAY STILL BE PRODUCED. HOWEVER, THE APPROPRIATE ROYALTY FEES WILL BE APPLIED BY THE VENDOR.
